WAIVER OF LIABILITY, INDEMNITY AND ASSUMPTION OF RISK AGREEMENT

In consideration of being permitted to use, observe and/or participate in any of Rhythm Motion's classes and/or other related activities (collectively the "ACTIVITIES"), the undersigned, **individually and on behalf of the above-listed Child as his/her parent or legal guardian, and any personal representatives, heirs, next of kin, successors and assigns** (hereinafter collectively "Child") hereby agrees as follows:

1. **Inspection & Physical Participation:** I hereby represent that I have inspected and carefully considered, or will immediately inspect and carefully consider, Rhythm Motion's facilities, equipment, premises and/or ACTIVITIES, and that My and/or My Child's participation in, observation, and/or use of such facilities, equipment, premises and/or ACTIVITIES constitutes My acknowledgement that such facilities, equipment, premises, and/or ACTIVITIES are accepted by Me to be safe and reasonably suited for My and/or My Child's participation, observation and/or use. I hereby acknowledge and agree that My and/or My Child's participation in and/or use of the ACTIVITIES and/or equipment will involve physical activities, including, but not limited to, gymnastics, advance dancing, and cheer pyramids, and that My and/or My Child's participation in and/or use of the ACTIVITIES and/or equipment constitutes My acknowledgement and representation that My Child and I are physically fit and able to participate in and/or use the ACTIVITIES and/or equipment. **I hereby acknowledge that My Child and I should consult with a qualified medical provider prior to participating in and/or using the ACTIVITIES and/or equipment.**

2. **Waiver and Release of Liability:** I, on behalf of Myself and My Child, hereby waive, release, discharge and agree not to sue Rhythm Motion and its owners, officers, principals, trusts, representatives, partners, employees, agents, parent companies, subsidiaries, successors, insurers, predecessors, indemnities, affiliates, assignees, directors, heirs and any and all other persons and/or entities acting by, through, or in any way on behalf them (collectively the "RELEASEES") from any and all liability, loss and/or damages arising from, but not limited to, My and/or My Child's participation in, observation and/or use, in any way, of the ACTIVITIES, equipment, facilities and/or premises that results in bodily injury, illness, death, and/or property damage of any kind, whether caused by the negligence of the RELEASEES or otherwise.

3. **Agreement to Indemnify, Save, and Hold RELEASEES Harmless:** I, on behalf of Myself and My Child, agree to **INDEMNIFY AND HOLD THE RELEASEES HARMLESS** from any and all claims, actions, suits, procedures, costs, expenses, damages and/or liabilities, including attorney's fees, that arise from My and/or My Child's participation in, observation and/or use, in any way, of the ACTIVITIES, equipment, facilities and/or premises, whether caused by the negligence of the RELEASEES or otherwise.

4. **Voluntary and Full Assumption of the Risk of Bodily Injury, Death or Property Damage:** I hereby acknowledge that observing, using and/or participating in Rhythm Motion's ACTIVITIES, equipment, facilities and/or premises carries with it the risks of bodily injury, death and/or property damage that cannot be eliminated despite the care taken to avoid such risks. The specific risks vary, but may include (a) minor bodily injuries, such as bruising, bumps, scratches, sprains, and/or cuts, (b) serious bodily injuries, such as concussions, bone fractures, eye injuries or loss of vision, and/or back or joint injuries, and/or (c) catastrophic injuries, such as paralysis and/or death. I hereby represent that My and/or My Child's participation in, observation and/or use of Rhythm Motion's ACTIVITIES, equipment, facilities and/or premises is **VOLUNTARY**. By observing, using and/or participating in Rhythm Motion's ACTIVITIES, equipment, facilities and/or premises, **I, on behalf of Myself and My Child, hereby assume full responsibility for, and assume all the risks of, bodily injury, death or property damage to Me and/or My Child due to the negligence or carelessness of the RELEASEES, dangerous or defective equipment or property owned, maintained, and/or controlled by the RELEASEES, and/or because of the RELEASEE'S possible liability without fault.** I hereby represent that I have read this paragraph and I know, understand and realize these, and other risks associated with, My and/or My Child's participation in, observation and/or use of Rhythm Motion's ACTIVITIES, equipment, facilities and/or premises.

5. **Photographs:** I understand that My and/or My Child's photograph may be taken by observing, using and/or participating in Rhythm Motion's ACTIVITIES, equipment, facilities and/or premises, and that **I, on behalf of Myself and My Child, agree that such photographs may be used by Rhythm Motion for marketing purposes.**

6. **Severability:** I hereby acknowledge and agree that the foregoing is intended to be as broad and inclusive as permitted by the laws of the State of California. I further acknowledge and agree that, if any provision of this Waiver of Liability, Indemnity and Assumption of the Risk Agreement shall be declared illegal, invalid, unenforceable and/or void by a court of competent jurisdiction, such provision shall be deemed severed and deleted from the contents herein, but this Waiver of Liability, Indemnity and Assumption of the Risk Agreement shall, in all other respects, remain unmodified and continue in full force and effect.

7. **Modification and Choice of Law:** This Waiver of Liability, Indemnity and Assumption of the Risk Agreement shall not be modified by any oral representation made before or after the execution of this Waiver of Liability, Indemnity and Assumption of the Risk Agreement. This Waiver of Liability, Indemnity and Assumption of the Risk Agreement shall, in all respects, be interpreted, enforced, and governed by the laws of the State of California.

8. **Acknowledgment of Understanding and Authorization:** By My signature below, I hereby represent, acknowledge and agree that (a) I have read all of the contents herein, fully understand its terms, and understand that **I, on behalf of Myself and My Child, waive and release substantial rights, including, but not limited to, the right to sue,** (b) I am signing this Waiver of Liability, Indemnity and Assumption of the Risk Agreement **freely and voluntarily, and intend to completely and unconditionally waive and release all liability stated herein to the greatest extent allowed by law,** (c) I am the above-listed Child's parent and/or legal guardian, and I have the legal authority to execute this Waiver of Liability, Indemnity and Assumption of the Risk Agreement on behalf Myself, My Child, any personal representatives, heirs, next of kin, successors and assigns; and (d) I agree to indemnify and hold the RELEASEES harmless if any of the information I provided herein is false.
